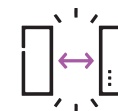

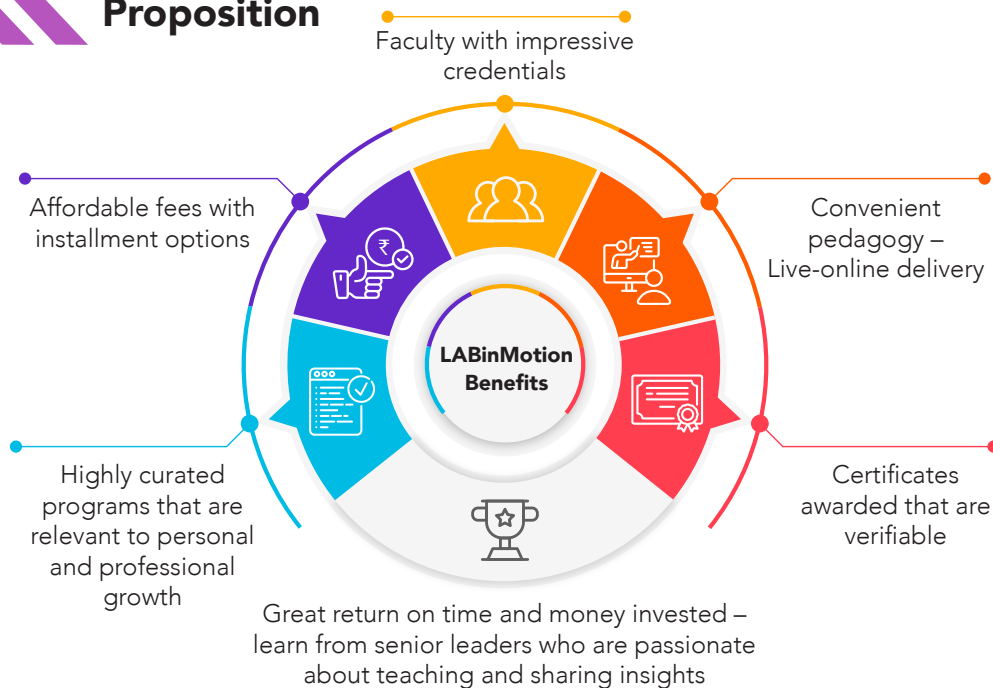

She is a Computer Science engineer from Delhi Institute of Technology (now NSIT) and a PGDM from Indian Institute of Management, Bangalore.

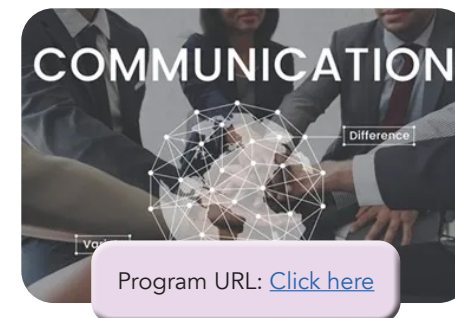
